The faculty advisory committees for the Curriculum in Contemporary European Studies, the Transatlantic Masters Program, and the Center for European Studies requests approval to create a dual BA-MA program that enables students to complete an undergraduate degree in Contemporary European Studies (EURO) and the research-focused track of the TransAtlantic Masters (TAM 2) within five years.

The proposed EURO-TAM accelerated BA-MA degree program stands out for its unique international component. Students in the program would complete four years of coursework at UNC-Chapel Hill, followed by one year of graduate study and research at one of three renowned European universities. Based on career placement data on TAM alumni from the past fifteen years, we expect that EURO-TAM graduates will be well-prepared for successful international careers.

Feedback from current EURO majors suggests that many students will embrace the challenge of completing a demanding and competitive program that increases the affordability of graduate school. Given the uniqueness of the program, we anticipate that the dual EURO-TAM degree will attract outstanding students to UNC from across North Carolina and the United States.

I have attached a copy of our proposal for your review. Please note that we have submitted a separate request to revise the current requirements for the EURO major. The EURO-TAM proposal is based on these projected changes but will be amended to reflect the Board's final decision regarding the curriculum.

The EURO-TAM Five-Year BA-MA

The EURO-TAM degree program enables students to complete a BA in Contemporary European Studies and the research-focused track of the TransAtlantic Masters within five years. A unique intensive program comprised of four years of coursework at UNC-Chapel Hill (including the option of participating in an approved undergraduate study abroad program) and one year of graduate study at one of three renowned European universities, the EURO-TAM degree prepares students for international careers in a variety of fields, including administration, diplomacy, business, policy-making, public service, marketing consulting, teaching, and research. We expect the program to attract outstanding students to UNC-CH from across North Carolina and the U.S.

The BA in Contemporary European Studies (EURO)

The Curriculum in Contemporary European Studies provides students with 1) a broad cross-disciplinary understanding of modern Europe and the European Union; 2) a focused understanding of contemporary Europe from the perspective of a selected social science discipline; and 3) advanced proficiency in a modern European language. Students are especially encouraged to combine the major with a second major in a non-interdisciplinary field such as political science, economics, or history. Through its unique combination of advanced coursework, quantitative analysis, and language training, the EURO curriculum provides the intellectual building blocks to study contemporary Europe through a sophisticated framework. Students completing the major will be well-prepared for further graduate or professional study of contemporary Europe and for a wide range of international careers.

- Four courses must be taken from one of the two themes listed below (asterisked courses require approval, based on the appropriate course topic).

- Of the total 8 courses required for the major in Contemporary European Studies, three must be numbered 400 or above.

Additional Requirements

• A modern European foreign language through level 5

Contemporary European studies majors are required to complete a minimum of five semesters of a western European language, or document fifth-semester proficiency through university placement tests. One approved literature course taught in the language may also count as a theme or elective course if included in the course listings above. Majors are strongly encouraged to apply their language proficiency skills in languages across the curriculum (LAC) courses and complete a UNC-approved study abroad program in the target language.

The TransAtlantic Masters, Research Track (TAM 2)

The research-oriented track of the TransAtlantic Masters Program focuses on European governance and social policy, with an emphasis on qualitative and quantitative research methods. Students study for one full academic year at UNC-Chapel Hill (for EURO-TAM students, this year would coincide with the senior year), followed by a year of study and research abroad at one of three institutions: the VU University in Amsterdam, the Universitat Pompeu Fabra in Barcelona, or the University of Bremen in Germany. All classes offered abroad are taught in English.

During the first semester at UNC-CH, students take three required courses and one elective. They also participate in the fall Speakers Series offered by the Center for European Studies. Courses focus on such topics as comparative politics of industrial societies, comparative social policy, democratization, the European Union, and multilevel governance. Over the fall break, students travel to Washington, D.C. for site visits and an annual gathering with TAM alumni. Two required courses and one elective are offered in the spring semester and students may elect to pursue independent study projects with individual professors.

After the first academic year ends in early May, students are encouraged to pursue relevant summer internships in Washington, D.C. or Brussels. The associate director of TAM provides guidance on locating internship opportunities.

During the fall of year two, coursework begins at VU Amsterdam, UPF, or the University of Bremen. All three universities have strong offerings in social policy. In Amsterdam, courses focus on comparative welfare states, international political economy, international security, and global environmental governance. Some research internships may be available to TAM students who study at the VU. At UPF, course titles may include *Statistical Analysis I*, *Electoral Systems*, *Multiculturality and Immigration Policies*, *The Welfare State*, *Globalization and European Integration*, *Democracy and Political Liberalism*, *Social Policy and the Welfare State*, *Electoral Competition and Voting Behaviour*, and *Migration and Society*. In Bremen, research internships are readily available and serve as an integral part of the program. In addition, social policy

coursework focuses on the economy and on health policy. During the second semester overseas, TAM II students focus on their thesis research and preparation.

Student Demand

Interviews conducted with EURO majors indicate a high level of interest in the opportunity to combine the BA and TAM into a five-year dual degree. Given the typical profile of EURO students, we expect that many will embrace the challenge of completing a demanding and competitive program that increases the affordability of graduate school. To date, the rigorous EURO curriculum has tended to attract highly motivated and academically exceptional students. EURO graduates, on average, enter UNC-CH with 19.7 Advanced Placement or by-exam credits. Because the degree requires at least four courses to be taken at the 400-level or above, many of our majors already enroll in upper-level courses alongside TAM students; during their undergraduate career, roughly half of EURO alumni completed coursework that satisfied requirements for the TAM degree (POLI 438, RUES 469, POLI 891 taken as 495). All of our past EURO graduates succeeded in completing double majors and more than 34 finished a minor. With the exception of one student, all also participated in study or work abroad during their undergraduate careers. After graduating from UNC-CH, more than 70% went on to pursue graduate or professional degrees—including the TransAtlantic Masters—in a variety of fields such as Economics, German Studies, Information Science, Law, Museum Studies, Political Science, and Public Administration.

Publicity and Student Recruitment

The EURO-TAM Program will be advertised to current and incoming UNC students through the usual channels: the admissions office, student orientation, academic advising, the annual Majors Expo, the CES website and biweekly e-newsletter, and the EURO and TAM webpages. Additionally, the Center for European Studies (CES), as a U.S. Department of Education National Resource Center and network coordinator of the ten European Union Centers of Excellence in the United States, will utilize its resources and outreach activities to market the EURO-TAM Program to high school students, teachers, and advisors within North Carolina and nationwide. Special efforts will be made to reach magnet, charter, and International Baccalaureate schools, schools with strong foreign language programs, and students participating in AP courses, EuroChallenge, Model EU, and Model UN. On-site presentations and classroom visits will be offered to schools in NC, and CES staff will work with the EURO advisor and TAM associate director to identify and recruit promising candidates.

Application and Admission

Undergraduate students who are interested in the EURO-TAM BA-MA program should contact both the EURO advisor and the TAM associate director as soon as possible, in order to strategically plan their program of study. Students should continue to meet with the EURO advisor at least once each semester to track their progress. To be eligible for admission into the EURO-TAM program, candidates should meet the following requirements before beginning the first year of TAM study:

- Complete all General Education and EURO requirements;
- Maintain a minimum GPA of 3.2.

Students must apply for admission to the TAM program in January of their sixth semester. The annual deadline will be posted on both the EURO and TAM websites at http://www.unc.edu/euro/ and http://www.unc.edu/depts/tam/. Applicants will be required to submit the following materials to the Graduate School:

- 1. Graduate School application;
- 2. Undergraduate transcript(s);
- 3. TOEFL or IELTS scores (only applies to international students from non-English-speaking countries);
- 4. Two letters of recommendation from faculty members affiliated with the EURO curriculum;
- 5. A 500-word statement of purpose;
- 6. A 10-page excerpt from an academic essay written for an approved EURO course.

The application fee will be waived for all currently-enrolled EURO majors. Although GRE scores will not be required, EURO-TAM applicants will be encouraged to submit them as supporting materials.

In addition to the six items above, the following materials must be submitted to the TAM office:

- 7. TAM Program application;
- 8. TAM foreign language evaluation(s);
- 9. Financial certificate (only applies to non-residents of the U.S.).

Application materials will be reviewed by the Graduate School and the TAM Admissions Committee, which consists of European Studies faculty.

The EURO-TAM program will take ten semesters to complete. Admitted students who have earned 60 baccalaureate credits (2 years or the equivalent) may begin taking courses at the post-baccalaureate level. Up to three graduate-level courses (9 credit hours) taken during the BA phase of the program may subsequently be counted toward the MA, as long as students also take enough courses within eight semesters to meet the 120-credit BA graduation requirement. The 9 transferred credit hours may not count toward the 120-credit hours for the undergraduate degree. Upon completion of all coursework and the thesis, students will earn a UNC-Chapel Hill Bachelor of Arts in Contemporary European Studies and a Master of Arts in Political Science, Concentration on European Governance.

As the plan indicates, EURO-TAM students who enter UNC with sufficient AP credit and foreign language proficiency may be able to complete an undergraduate double major, a language minor, and study abroad for a semester, in addition to earning the TAM degree.

Outlook for Graduates

Over 200 TAM degrees have been awarded since the program was launched fifteen years ago. Career placement data suggests that EURO-TAM degree recipients can expect promising employment opportunities. According to a recent survey of TAM graduates, approximately ¼ currently serve in the U.S. Government, ¼ are employed at NGOs or think tanks, ¼ hold positions in the private sector, and ¼ work in higher education.

The success of past graduates is undoubtedly maximized by the individualized career guidance and special professional development opportunities offered through the TAM program. In addition to their academic training, TAM candidates participate in CV and cover letter workshops, site visits to Washington, D.C. and New York City, alumni roundtable discussions, focus groups, and networking events. Our active and generous network of TAM alumni can also assist recent graduates in cultivating professional contacts and locating employment prospects.

EURO-TAM Five-Year Degree: Sample Course Plan

This student enters UNC-CH with 15 AP credits and places into 4^{th} semester French. She earns a TAM 2 degree, a double major in EURO and POLI, and a minor in French, and studies abroad during the fall semester of her 3^{rd} year.
