We are requesting approval to add new courses to the thematic areas for the Social and Economic Justice minor. Additionally, we are requesting approval to un-list independent study, special topics, and internship courses officially listed for the minor. Given the variable nature of the subjects of these courses, we would like students to seek approval from the Director of the minor to ensure these courses fit with the themes and goals of the minor. Dr. Kleinman has reviewed the syllabi for the courses affected by these revisions and Kenneth Andrews, Chair of the home department for the minor, approves of these changes.

The minor has three areas: Understanding Justice; The Context of Justice; and Justice in Action.

We propose adding the following courses to Understanding Justice. These courses focus on an analysis of inequality (injustice) and/or what prevents or enables change:

- EDUC 533 Social Justice in Education (3)
- SOCI 424 Law and Society (3)

We propose adding the following courses to Justice in Action. These courses either offer an outlet for action (e.g., through drama, service, or other media) or focus on justice movements:

- ANTH 240 Action Research (3)
- GEOG 650 Technology and Democracy Workshop (3)

We propose adding the following courses to Context of Justice. These courses place analyses of inequality and justice in a variety of contexts:

- ANTH 120 Anthropology through Expressive Cultures (3)
- ENGL 465 Difference, Aesthetics, and Affect (3)
- GEOG 232 Agriculture, Food and Society (3)
- GEOG 457 Rural Latin America: Agriculture, Environment, and Natural Resources

We propose un-listing the following courses from the minor, and replacing these specific listings with the following sentence in the body of the *Undergraduate Bulletin* text: "Depending on the topic, independent study, special topics, and internship courses may be approved to fulfill the requirements of the minor with the explicit permission of the Director." We feel that this revision will better ensure that all courses used to fulfill the minor requirements are consistent with the themes and goals of the minor, given the variable nature of the subject of these courses.

We are concerned that this statement causes confusion among minors, as the Campus Y does not offer programs that fulfill the requirements of the minor.

# Minoring in Social and Economic Justice

The minor in social and economic justice is designed for students who want to understand how to think analytically about issues of justice and how perspectives on justice can be joined with the pursuit of it. An overarching objective is fostering attitudes and knowledge about human rights; racial, ethnic, and gender equality; economic justice; democratic participation; sustainable development; diversity; and peace. It is especially appropriate for students who anticipate working in advocacy roles in nonprofit organizations, in local communities, or in governmental organizations. In these inquiries about justice, students engage scholarship in a variety of disciplines and traditions of practice.

Students are required to complete one service-learning experience, a requirement that can be met in one of three ways. First, a student may take a course that includes a service-learning (APPLES) component. Second, after seeking and receiving the approval of the director of the minor, a student may take a one- to three-credit independent studies or special topics course (summer or academic term) with a faculty member. The third option is the two-credit spring break course, HBEH 610 Alternative Spring Break, which meets the service-learning requirement but not a course requirement. Note that core courses do not necessarily contain a service-learning component; check ConnectCarolina each semester to confirm that courses are listed as APPLES courses. Four courses are required:

• One core course chosen from GEOG/PWAD 453, GEOG/WMST 225, PHIL 273, SOCI 273, or SOCI 274
