I hope your semester is off to a good start! I meant to contact Tricia Sullivan in December after reviewing the changes she submitted for the 2016-17 Undergraduate Bulletin, but it slipped my mind until now.

Based on the edits she submitted (see attached Word document), it appears that the department wants to make a few **changes to the electives requirement course list**.

- **Add** ECON 345 and 455
- **Remove** AAAD 498; ANTH 344, 340; BUSI 551; HBEH 611; HIST 580; HNRS 352.01S, 352.02S, 357; HPM 404, 465; POLI 405, 430, 447; PUBH 680; PWAD 395; STOR 456; SOCI 490; and WMST 436

This is not a problem, but because this is considered a **curriculum revision**, we'll need approval from the PLCY department chair and the Administrative Boards of the College of Arts and Sciences. To simplify the process, if you can ask Dan Gitterman to confirm these changes by email, I will take this action item to the Administrative Boards for approval with a fall 2016 effective date.
